Conformity assessment according to module D – conformity to type based on quality assurance of the production process based on MID and NAWID directives

I MODULE D - conformity to type based on quality assurance of the production process based on MID and NAWI directives

Conformity to type based on quality assurance of the production process is the part of a conformity assessment procedure whereby the manufacturer fulfils the obligations laid down in directive, and ensures and declares on his sole responsibility that the measuring instruments concerned are in conformity with the type described in the EU-type examination certificate and satisfy the requirements of this directive that apply to them.

The manufacturer shall operate an approved quality system for production, final product inspection and testing of the measuring instruments concerned and shall be subject to surveillance by notified body.

II The scope of notification - Module D

The scope of notification of NB 1440 to carry out the conformity assessment according to *module D – conformity to type based on quality assurance of the production process* under MID and NAWI directives covers the following measuring instruments.
